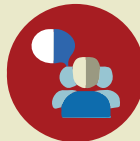

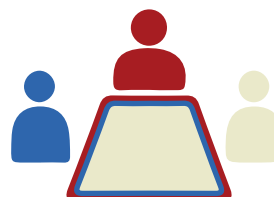

## WHAT HAPPENS NEXT?

- COMMISSIONERS MAY DECIDE TO SPONSOR A PUBLIC PROPOSAL
- COMMISSIONERS MAY CONSIDER COMMENTS AND PROPOSALS SUBMITTED BY THE PUBLIC WHILE CREATING THEIR OWN PROPOSALS
- ANY PROPOSALS THAT PASS THE CRC'S FINAL VOTE MUST SECURE AT LEAST 60% VOTER APPROVAL ON THE 2018 GENERAL ELECTION BALLOT TO BECOME LAW
